

TASL Fall 2021 COVID-19 Waiver

TASL acknowledges the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing.

TASL further acknowledges that Arsenal FC has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.

Arsenal FC further acknowledges that TASL cannot guarantee that its coaches, players, and spectators will not become infected with the Coronavirus/Covid-19.

Arsenal FC understands that the risk of becoming exposed to and/or infected by the Coronavirus/ COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, referees, coaches, players and spectators.

Arsenal FC voluntarily seek services provided by TASL and acknowledges that our participating teams are increasing their risk to exposure to the Coronavirus/COVID-19.

Arsenal FC acknowledges that they must comply with all set procedures to reduce the spread while attending a TASL event, sanctioned by VYSA.

Arsenal FC attests that, to the best of my knowledge:

- players, teams, coaches and officials are not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- players, teams, coaches, and officials do not believe they have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- players, teams, coaches, and officials have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- Arsenal FC is following all CDC recommended guidelines as much as possible and limiting exposure to the Coronavirus/COVID-19.

Arsenal FC hereby releases and agree to hold TASL harmless from, and waive on behalf of itself, its coaches, players, spectators and any other representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to itself and/or property that may be caused by any act, or failure to act of TASL, or that may otherwise arise in any way in connection with any services received from TASL.

Arsenal FC understands that this release discharges TASL from any liability or claim that Arsenal FC, its players, coaches, spectators or other interested parties may have against TASL with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from TASL. This liability waiver and release extends to TASL together with all its officers and directors.
